

PERTH WILDCATS HOME GAME GOLD TICKETS GIVEAWAY PROMOTIONS
TERMS AND CONDITIONS OF ENTRY

1. These **Promotions** are named as follows:
 - a. the Perth Wildcats Home Game Gold Tickets Giveaway – September 2024 Promotion (**September Promotion**);
 - b. the Perth Wildcats Home Game Gold Tickets Giveaway – November 2024 Promotion (**October Promotion**);
 - c. the Perth Wildcats Home Game Gold Tickets Giveaway – December 2024 Promotion (**November Promotion**);
 - d. the Perth Wildcats Home Game Gold Tickets Giveaway – January 2025 Promotion (**January Promotion**); and
2. Information on how to enter and the prizes form part of these Terms and Conditions.
3. The **Promoter** is Police & Nurses Limited (**P&N Bank**), ABN 69 087 651 876, AFSL/Australian Credit Licence 240701, Level 6, 556 Wellington Street, Perth WA 6000, telephone 13 25 77.
4. The Promotion is being conducted in Western Australia only.
5. The **Promotion Period** for each Promotion is as follows:
 - a. for the September Promotion, the Promotion Period commences at 9.00am (AWST) on 18/09/2024 and closes at 9.00am (AWST) on 25/09/2024;
